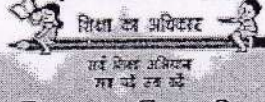

- मान्यता विस्तारित नहीं होगी तथा कक्षा 8 से आगे की मान्यता/संबद्धता की कोई बाध्यता किसी भी रूप में विवक्षित नहीं होगी।
